GENERAL:

This addendum will form a part of the Contract Documents and modifies the original Request for Qualifications (RFQ) Documents dated June 26, 2017. The following conditions and/or changes take precedence over items in the original RFQ Documents. Portions of the RFQ not changed by this Addendum remain in effect. Recipients of this Addendum are advised to provide this Addendum to anyone to whom they further distribute without the BAA's knowledge.

Respondents are required to acknowledge receipt of this Addendum in their Statement of Qualifications (SOQ) submittals. Failure to do so may subject the Respondent's SOQ to disqualification.

QUESTIONS From Pre-Submittal Conference:

- Q1. The RFQ under "Submission of Qualifications Statement ask for submittals to be limited to not more than 20 double sided pages or less, and bounded with spiral /comb biding". Does the table of contents and cover pages count as part of the twenty (20) double-sided pages?

A1. The Table of contents, Cover sheets, and pages alike will not count toward the twenty (20) page double sided limit.

CLARIFICATIONS:

See Section F, Page 11, and Paragraph at bottom of page, revised as follows:

1. **Existing RFQ language in Section F:** Selection Process; at bottom of page 11, which reads as follows:

A Fee Proposal will be submitted at the oral presentation **in a sealed envelope** labeled “Aircraft Rescue and Fire Fighting (ARFF) Station” Statement of Qualifications for the Professional Architectural- Engineering Consulting Services for the ARFF Station Project” Birmingham-Shuttlesworth International Airport, with the name of the Submitting Firm or team of firms, to:

This statement is being restated for clarity as follows:

A Fee Proposal will be requested from the most qualified competitor selected after oral presentations. The Fee Proposal is to be submitted **in a sealed envelope** labeled “Aircraft Rescue and Fire Fighting (ARFF) Station” Statement of Qualifications for the Professional Architectural- Engineering Consulting Services for the ARFF Station Project” Birmingham-Shuttlesworth International Airport, with the name of the Submitting Firm or team of firms, to:

2. **Existing RFQ language in Section F:** Selection Process; on page 12, below mailing address, which reads as follows:

Only proposal of those Short Listed Firms that meet the qualifications will be retained. The fee Proposal envelope will be opened only during negotiations with the successful firm or team of firms. The unsuccessful firms or team of firm’s proposal will be returned unopened”.

This paragraph above is being deleted in its entirety.
