All bids are to be submitted to the Birmingham Airport Authority's Main Administration Offices no later than 2:00 p.m. Bids will be opened and read aloud starting at 2:15 p.m., Thursday, September 19, 2019, in Meeting Room A. Meeting Room A is situated in the Birmingham-Shuttlesworth International Airport lower level, adjacent to the Birmingham Police Department Substation, near the Concourse C escalators. Submitted Bids are to be addressed to the attention of Mr. Lowrenzo Taylor, Project Manager, Birmingham Airport Authority, Birmingham, Alabama 35121.

The work consists of, but is not limited to, the abatement of hazardous materials, namely asbestos and lead, demolition of the structures, clearing, grubbing, and improvements of the lot.

A pre-bid conference will be held on Thursday, September 5th, 2019 starting at 2:00 p.m. and ending at 4:00 p.m. local time at Meeting Room A located at the Birmingham-Shuttlesworth International Airport, 5900 Messer Airport Highway, Birmingham, Alabama 35212.
