SEALED BIDS will be received on behalf of the Birmingham Airport Authority (BAA) at the BAA's Administration Office, located on the Airport's lower level main terminal building, at the Birmingham- Shuttlesworth International Airport, 5900 Messer Airport Highway, Birmingham, Alabama 35212, until 1:00 p.m. local time on Thursday, June 25, 2020. Sealed Bids will be opened and publicly read aloud starting at 2:00 p.m. in Meeting Room B, situated on the Terminal Building's lower level, adjacent to the Birmingham Police Department Substation, near the escalators. The bids shall be submitted in a sealed envelope and/or container plainly marked on the outside with the name, address, and license number of the bidder; the name of the project ("Runway 18-36 & Taxiway 'G' Pavement Rehabilitation") and the time and date due (1:00 p.m. local time, Thursday, June 25, 2020). Submitted Bids are to be addressed to the attention of Mr. Marcelo Lima, Vice President of Planning and Development, Birmingham Airport Authority, Birmingham, Alabama 35212.

At this time, the onsite pre-bid meeting shall be considered tentative due to impacts from the novel Coronavirus (COVID-19). The pre-bid meeting may be held virtually and/or by teleconference. Details of the pre-bid meeting will be updated on the Quest website described below. Please check the website within 24 hours of the scheduled pre-bid meeting for details of the meeting and/or for directions of how to access the teleconference or virtual meeting. **All prospective bidders are required to attend this conference regardless of meeting type.**

Site visits will be available, by appointment only, on Thursday, June 11, 2020. Prospective bidders wishing to make site visit shall schedule appointments with BAA Operations by 5 p.m. local time on Tuesday, June 9, 2020. Additional requirements and details for site visit will be discussed at pre-bid conference.

Complete digital plans and contract documents shall be purchased and obtained electronically from Volkert's website, www.volkert.com, by clicking the "BID INVITATIONS" link at the bottom of the page or from www.questcdn.com by inputting Quest project number #7096161 on the website's project search page. A payment of \$15.00 will be required to download the plans and contract documents.

The Contractor must purchase and obtain the plans and specifications from the website listed above in order to submit a bid. Bids must be submitted upon the forms included within the contract documents and specifications. The contract documents and specifications must be submitted in their entirety.

All bidders bidding in amounts exceeding \$50,000.00 must be licensed under the provisions of Title 34, Chapter 8, Code of Alabama, 1975, as amended. A Heavy/Railroad (H/RR) license classification from the State Licensing Board for General Contractors, Montgomery, Alabama will be required and must be obtained before the contract is awarded.

The project shall be completed within 100 Calendar Days.

No bid shall be withdrawn for a period for 180 days subsequent to the opening of bids without the consent of the BAA.

Each bid shall be accompanied by a Bid Bond, submitted in the form of a guaranty and/or promissory note from a banking, insurance or other lending or financial institutions, equal to at least five (5%) per cent of the bid price and made payable to the Birmingham Airport Authority. No cash, check, or money orders will be accepted. All bidding participants will be required to adhere to the following provisions listed below:

DBE Policy: It is the policy of the BAA that DBEs, as defined in 49 CFR Part 26, will have maximum opportunity to participate in the performance of all Authority projects and the Bidder will take all necessary and reasonable steps to ensure that DBEs have the maximum opportunity to compete for and perform subcontracts. The Owner's award of this contract is conditioned upon the Bidder satisfying the good faith effort requirements of 49 CFR §26.53. As a condition of bid responsiveness, the Bidder must submit the following information with its proposal on the forms provided herein:

- 1) The names and addresses of Disadvantaged Business Enterprise (DBE) firms that will participate in the contract;
- 2) A description of the work that each DBE firm will perform;
- 3) The dollar amount of the participation of each DBE firm listed under (1)

- 4) Written statement from Bidder or Offeror that attests their commitment to use the DBE firm(s) listed under (1) to meet the Owner's project goal; and
- 5) The bidder shall make good faith efforts, as described in Appendix A to 26.45 - Guidance Concerning Good Faith Efforts - 49 CFR Part 26, Regulations of the Office of the Secretary of Transportation, to subcontract 25% of the dollar value of the prime contract to small business concerns owned and controlled by socially and economically disadvantaged individuals (DBE).

Failure by the Contractor to carry out these requirements is a material breach of this contract, which may result in the termination of this contract or such other remedy, as the recipient deems appropriate.
